





Fig. 3. Logic diagram (one inverter)





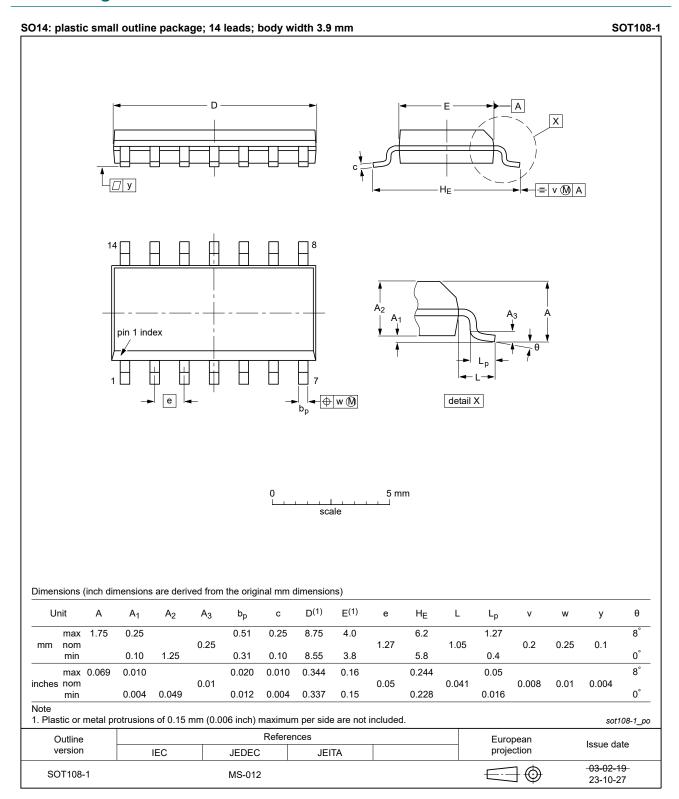


Fig. 6. Package outline SOT108-1 (SO14)




Fig. 7. Package outline SOT402-1 (TSSOP14)




Fig. 8. Package outline SOT762-1 (DHVQFN14)
