## 1. General description

The 74HC4002-Q100 is a dual 4-input NOR gate. Inputs also include clamp diodes, this enables the use of current limiting resistors to interface inputs to voltages in excess of  $V_{CC}$ .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.














Fig. 10. Package outline SOT402-1 (TSSOP14)
