

1. General description

The 74HC11-Q100; 74HCT11-Q100 is a triple 3-input AND gate. Inputs include clamp diodes that enable the use of current limiting resistors to interface inputs to voltages in excess of V_{CC} .

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.










 V_{OL} and V_{OH} are typical voltage output levels that occur with the output load.




Fig. 6. Package outline SOT108-1 (SO14)

Triple 3-input AND gate




Fig. 7. Package outline SOT402-1 (TSSOP14)
