1. General description

The 74HC2G08-Q100; 74HCT2G08-Q100 is a dual 2-input AND gate. Inputs include clamp diodes. This enables the use of current limiting resistors to interface inputs to voltages in excess of V_{CC}.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.












Fig. 6. Package outline SOT505-2 (TSSOP8)




Fig. 7. Package outline SOT765-1 (VSSOP8)
