

## 74LVC139-Q100

Dual 2-to-4 line decoder/demultiplexer Rev. 1 — 24 January 2024

## 1. General description

The 74LVC139-Q100 decodes two binary weighted address inputs (nA0, nA1) to four mutually exclusive outputs (n $\overline{Y}$ 0 to n $\overline{Y}$ 3). Each decoder features an enable input (n $\overline{E}$ ). When n $\overline{E}$  is HIGH all outputs are forced HIGH. The enable input can be used as the data input for a 1-to-4 demultiplexer application. Inputs can be driven from either 3.3 V or 5 V devices. This feature allows the use of these devices as translators in mixed 3.3 V and 5 V environments.

Schmitt-trigger action at all inputs makes the circuit tolerant of slower input rise and fall times.

This product has been qualified to the Automotive Electronics Council (AEC) standard Q100 (Grade 1) and is suitable for use in automotive applications.










## Fig. 6. Test circuit for measuring switching times
