



Fig. 1. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values







Fig. 3. Forward current as a function of forward voltage; typical values




Reverse current as a function of reverse Fig. 4. voltage; typical values





Fig. 7. Package outline DFN1006BD-2 (SOD882BD)
