






Fig. 2. Transient thermal impedance from junction to ambient as a function of pulse duration; typical values





DC current gain as a function of collector Fig. 5. current; typical values



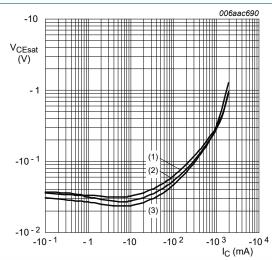
