





Fig. 4. Collector current as a function of collectoremitter voltage; typical values



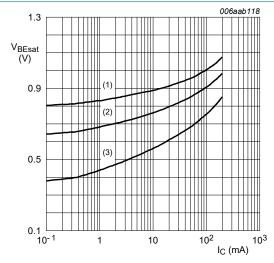




