


Fig. 1. 8/20 μ s pulse waveform according to IEC 61000-4-5




Fig. 2. ESD pulse waveform according to IEC 61000-4-2





Positive clamping voltage (TLP); typical values Fig. 5.





Capacitance as a function of reverse voltage; typical values



Transmission Line Pulse (TLP); $t_{\rm n}$ = 100 ns; $t_{\rm r}$ = 1 ns


Fig. 6. Negative clamping voltage (TLP); typical values


10. Application information


