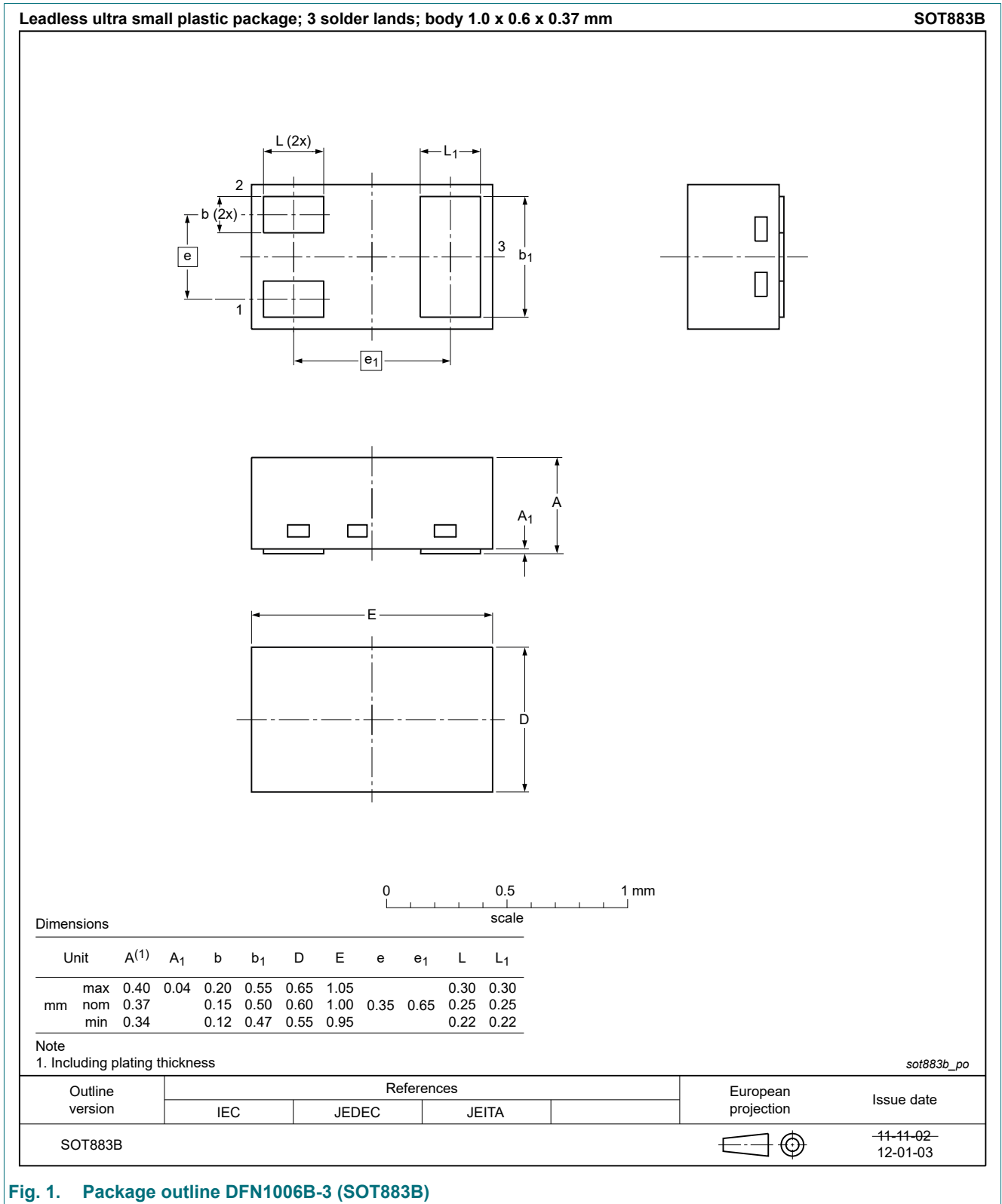


Fig. 1. Package outline DFN1006B-3 (SOT883B)

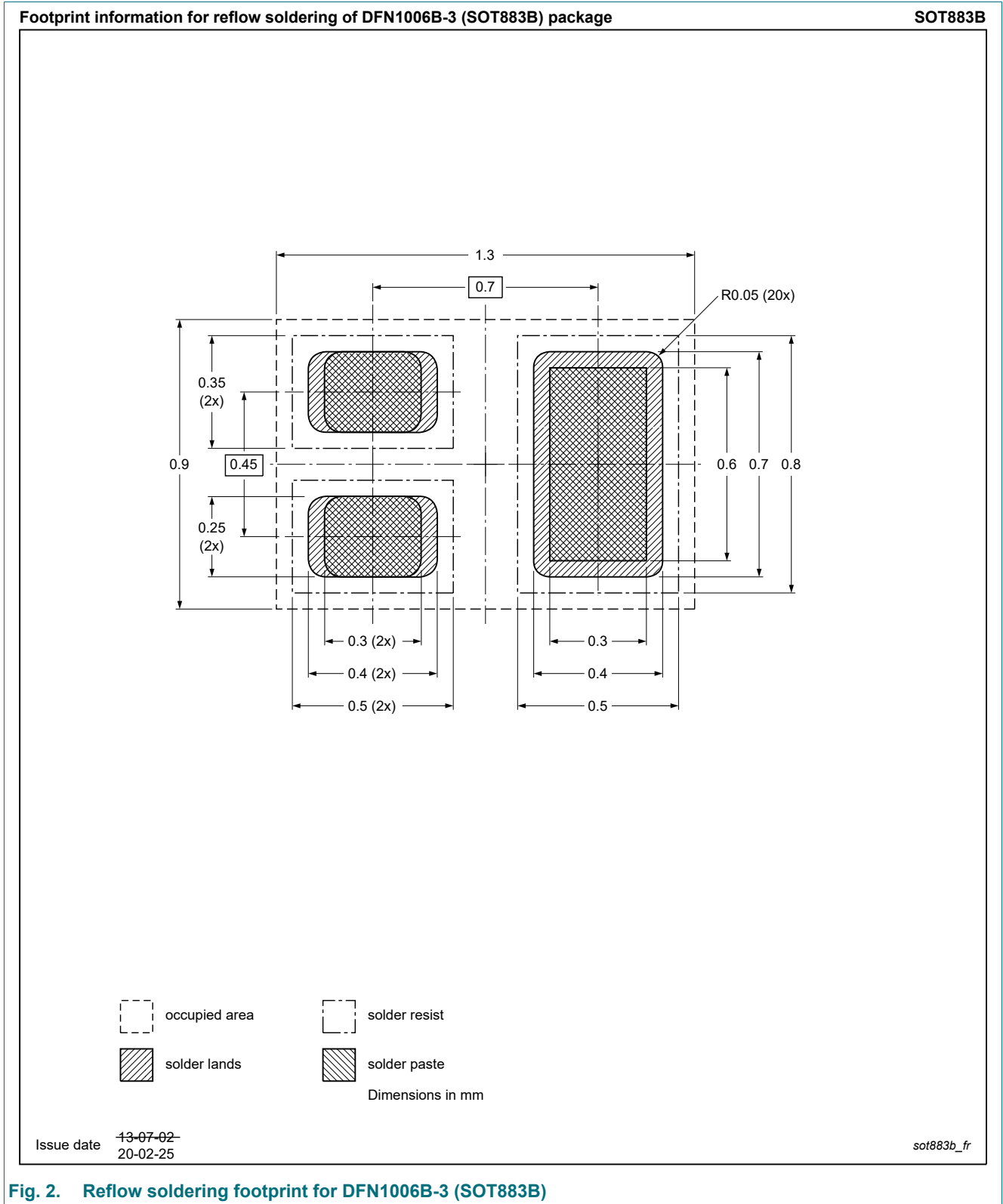


Fig. 2. Reflow soldering footprint for DFN1006B-3 (SOT883B)
